Services provided

Basic Mowing

Three-month minimum. This includes mowing the grass, trimming or edging all borders of the grass as well as blowing any mess created by the above work. We only provide this service on a weekly basis April – Thanksgiving. We do not haul off clippings. Your garbage collector can provide you with a container, which we would be happy to use. The minimum contract for this service is 3 months. We will give you the option of continuing the service through the winter months if you so desire.

Full Service program

Minimum commitment is 12 months for full service. This service includes basic service year round with the addition of weeding the beds, fertilizing the grass, moss control, trimming all hedges as well as minor pruning. If it requires a chainsaw then it is not included. We expect the customer to have ample mulch or weed control barrier or it will be nearly impossible to keep up with the weeds. We will also blow all concrete areas & patios each service as well as clean up fallen leaves in the fall. The lawn should be green & weed free & the property clean & manicured

Ala Carte Services

We can provide ala Carte services such as spring or fall cleanups for our basic mowing customers as well as adding mulch or bark (Minimum of 10 cubic yards \$400). Ala Carte Services are due immediately upon completion unless prior arrangements have been made.

Billing & Payment

Invoices are mailed on the 1st of each month & are due on the 20th. If payments are received after the 2nd of the following month a \$20 late fee will apply. We reserve the right to cancel customers that are late more than once with a fee that equals 1 month penalty for customers that agree to a 12 month contract and do not pay on time.

Annual Prepay Discount

We offer 15% off on annual prepays. Payments must be received by January 15th unless prior arrangements have been made. If you move out of our service area before a year has passed you will receive a refund within 30 days of your final service date.
